Cllr. B. Keys-Holloway reported that East Suffolk Council had a new scheme to help Parish Councils collect Second Hand Clothing for those in need. She said that there were also grants of up to £3000 and there was a new scheme too for the Council to help pay rent to landlords to make available empty properties.

Cllr. B. Keys-Holloway said that East Suffolk Services Ltd had taken over from Norse and East Suffolk Services Ltd would be using new fuels and more efficient vehicles. She said that East Suffolk Council was also trying to leave as much as possible road verges as wild habitat. Cllr. A. Coles asked that perhaps foliage could be cut back at road junctions for safety reasons.

Cllr. B. Keys-Holloway said that she and Cllr. G. Wakeling were very aware of that the people of Wissett were very much against Solar Farms as Cllr. G. Wakeling had attended a Wissett Parish Council Meeting. Cllr. A. Coles noted that all new houses had to have solar panels put on their roof tops.

Finally, Cllr. B. Keys-Holloway said that the Beccles, Bungay and Halesworth Community Partnership had a pot of money and was meeting on July 31<sup>st</sup> at 6pm in the Cut, Halesworth. It was agreed that Cllr. D. Carter would attend the meeting.
